## WDTIP System Functionality

On September 9, 2000, the WDTIP Application and Technical Teams successfully implemented the second release of the WDTIP system. This release incorporates eight enhancements to the system. Please see the August 31, 2000 WDTIP Bulletin for a complete description of changes included in this release.

The WDTIP User Manual is currently being updated to reflect these system changes. The updated version will be available on the Project website by October 6, 2000. Please contact the WDTIP Help Desk at (877) 365-7378 if you have questions.

The Application Team is preparing for the final release of the 2000 calendar year. The release is tentatively scheduled to be completed by the middle of December 2000. The Application Team is working with CDSS to finalize the modifications that have resulted from the distribution of ACL 00-48 "Tracking Diversion Payments and State-Only Funded Programs for the California Work Opportunity and Responsibility to Kids (CalWORKs) and Temporary Assistance to Needy Families (TANF) Programs." Proposed changes include modifications to the Diversion Update (UDIV) and Diversion Detail (DDET) screens, as well as changes to the way that time clocks are calculated for diversion payments.

ACL 00-60 "California Work Opportunity and Responsibility to Kids (CalWORKs) Welfare to Work (WTW) Plan Sign Date and the Start of the 18- or 24-Month Time Limit on Aid" was released on August 30, 2000. Discussions are currently underway with the Department of Social Services and counties/consortia to determine the impact of ACL 00-60 to the calculation of the Welfare to Work 18/24 month time clock.

## **WDTIP System Training**

Just a reminder, all counties have the option of conducting their end-user training in the Production Region (TRAC) or the Training Region (TRAT) of the WDTIP system. The Training Region will be available to accommodate county end-user training through June 30, 2001.
