WDTIP UPDATES

> TRAC System Updates:

Effective April 30, 2022, the CalWORKs Time Clock has been modified from 48 Month to 60 Month; per All County Letter (ACL) 20 -113. All TRAC Time Clock Program Logic has been updated and all impacted TRAC Screens (including Error Messages) have been modified to reflect this Policy change. Modified TRAC screens include: TRAC Main Menu, CalWORKs 60-Month Calendar, Time Clock Summary, Program Detail, Individual Detail, Diversion Detail, Navigation.

Due to this Policy change, four WDTIP Monthly Report Files, which are transmitted to the CalSAWS and CalWIN Consortia have been modified. These Monthly Report Files are: Approaching Clocks Report (Long Format), Exceeding Clocks Report, Exceeding Clocks (with Aid Code), and the Monthly Projections.

Effective April 30, 2022, the Welfare to Work (WTW) 24-Month Time Clock has been eliminated per All County Letter (ACL) 20 -120. Historical WTW Time Clock data and historical WTW Plan Sign Dates will remain in view in the TRAC system. This historical WTW 24-Month Time Clock data is displayed from January 01, 2013, through April 30, 2022.

> TRAC Code Updates:

Pursuant to ACL 21-82, the COVID-19 good cause time limit exemption is terminated when the 60-month CalWORKs time limit goes into effect. Thus, effective April 30, 2022, the following CalWORKs and WTW Time Clock Program Exception Code has been end dated:

04/407 – Time Good Cause

The effective end date for this Time Clock Exception code is 04/30/2022.
