#### Description

The Transaction Version is used to uniquely identify multiple occurrences of the same batch number. It is a two-digit number that is incremented by one according to the number of times that a given batch number has been sent. This exception occurs when WDTIP receives an extract file header with a Transaction Version number that is out of sequence, uses an invalid value, or is null.

#### Scenario

County sends WDTIP an initial file for the first time with a Transaction Version of 01. The file is rejected because the Transaction Version number should be 00.

### Examples

County sends the following Transaction Version for the initial file described above, with a Transaction Version of 01 in the file header.

EXTR0136V6Z361001P200102010901550002

#### Resolution

County should resend the initial file with the correct Transaction Version number of 00.

EXTR0036V6Z361001P200102010901550002



# Exception

102	County Code is not a valid value or is null.	HDR

#### Description

The County Code is a unique two-digit field used to identify the county sending the file. A listing of valid values for the County Codes is presented in the **TRAC Reference**Codes document. This exception is generated when a county sends an incorrect code or blanks for their county code in the extract file header.

#### Scenario

Santa Clara (county 43) sends a file to WDTIP, using 58 as the county code in the header. San Diego (county 37) sends a file to WDTIP with blank spaces for the county code in the file header.

### Examples

- 1. Santa Clara sends the following: EXTR0158V6Z431001P200102010901550002
- 2. San Diego sends the following: EXTR01--V6Z371001P200102010901550002

- 1. Santa Clara resends the extract file with the correct county code: EXTR0143V6Z431001P200102010901550002
- 2. San Diego resends the extract file with the correct county code: EXTR0137V6Z371001P200102010901550002

103	Account Code is not a valid value or is null.	HDR

#### Description

The account code data format should be V6ZCC1001P, where CC is the two digit county code. This exception occurs when a county sends, in the header of the extract file, an incorrect code or blanks for the mandatory ten-digit Account Code (used by WDTIP for billing).

#### Scenario

Santa Clara (county 43) sends a file to WDTIP, using 58 as the county code in the Account Code portion of the file header.

Fresno (county 10) sends a file to WDTIP with blank spaces for the Account Code in the file header.

# **Examples**

- 1. Santa Clara sends the following: EXTR0143V6Z581001P200102010901550002
- 2. Fresno sends the following: EXTR0110V6Z--1001P200102010901550002

- 1. Santa Clara resends the extract file with the correct Account Code: EXTR0143V6Z431001P200102010901550002
- 2. Fresno resends the extract file with the correct Account Code: EXTR0110V6Z101001P200102010901550002



#### Exception

104	Creation Date is not a valid value or is null.	HDR

#### Description

The Creation Date is an eight-digit date with a valid format of YYYYMMDD and indicates the date the file was created at the county system. This exception occurs when a county sends, an incorrect or blank Creation Date in the extract file header.

#### Scenario

Alameda (county 01) sends a file to WDTIP, with a Creation Date in an incorrect format. Sonoma (county 49) sends a file to WDTIP with blank spaces for the Creation Date in the file header.

# **Examples**

- 1. Alameda sends the following: EXTR0101V6Z011001P10202000901550002
- 2. Sonoma sends the following: EXTR0149V6Z491001P------10901550002

- 1. Alameda resends the extract file with the correct Creation Date: EXTR0101V6Z011001P2000102010901550002
- 2. Sonoma resends the extract file with the correct Creation Date: EXTR0149V6Z491001P2000102010901550002

#### Description

The Batch Number is a sequential four-digit number assigned by the county that, together with the Transaction Version, uniquely identifies the extraction file. The Batch Number is to be incremented by one each time a new extract file is sent. The first extract file sent should contain the value 0001. This exception occurs when a county sends an incorrect or blank Batch Number in the extract file header.

#### Scenario

Siskiyou (county 47) sends a second file to WDTIP, incrementing the Batch Number by two, instead of one in the file header.

Sierra (county 46) sends a file to WDTIP with blank spaces in place of the Batch Number in the file header.

# **Examples**

- 1. Siskiyou sends the following: EXTR0147V6Z471001P200005020909000004
- 2. Sierra sends the following: EXTR0146V6Z461001P20000406070150----

- 1. Siskiyou resends the extract file with the correct Batch Number: EXTR0147V6Z471001P200005020909000002
- 2. Sierra sends the following: EXTR0146V6Z461001P200004060701500002

#### Description

The exception occurs when there is a discrepancy in the Transaction Version, County Code, Account Code, Creation Date, Creation Time, and/or Batch Number of a county's header and trailer records.

#### Scenario

Plumas (county 32) sends a file to WDTIP, with a County Code of 32 in the file header and a County Code of 58 in the file trailer.

Ventura (county 56) sends a file to WDTIP with a Creation Date and Time that is different for the header and trailer records.

### **Examples**

1. Plumas sends the following:

EXTR0032V6Z321001P200102010901550001 TRAL0058V6Z581001P2001020109015500010000000789

2. Ventura sends the following:

EXTR0056V6Z561001P200102010901550001 TRAL0056V6Z561001P2001020210100000010000009989

#### Resolution

1. Plumas resends the extract file with corrected County Code in the trailer record: EXTR0032V6Z321001P200102010901550001 TRAL0032V6Z321001P2001020109015500010000000789

2. Ventura resends the extract file with the corrected Creation Date and Time:

EXTR0056V6Z561001P200102021010000001

TRAL0056V6Z561001P2001020210100000010000009989

The exception occurs when a county sends an extraction file with the same Batch Number and Version Number as a previous file.

#### Scenario

Plumas (county 32) sends a file to WDTIP, with a Batch Number of 0602 and a Version Number of 00 in the extract file header.

# **Examples**

Plumas sends the following: EXTR0032V6Z321001P200102010901550602

#### Resolution

Plumas resends the extract file with corrected Batch Number or Version Number (because a file with Batch Number 0602 and Version Number 00 was previously sent to WDTIP):

EXTR0032V6Z321001P200102010901550603 (different Batch Number)
-orEXTR0132V6Z321001P200102010901550602 (different Version Number)

### Description

The batch number is the unique sequential number assigned to an extraction file received from a county. This together with the Version Number uniquely identifies the extraction file. It is a four-digit number that is incremented by one every time a new extraction file is sent. The Version Number is used to uniquely identify multiple occurrences of the same batch. It is a two-digit number that is incremented by one according to the number of times that a given batch number has been sent. Batches of files are processed sequentially. This exception occurs when WDTIP receives an extract file where the header and/or trailer have a Batch Number and/or Transaction Version number that is out of sequence.

#### Scenario

County sends WDTIP an extract file on day 1 with Batch number 0010 and version number 00. The next extract file received by WDTIP has a Batch number of 0012 and version number 00. This file will be rejected and held because the batch number is out of sequence.

#### Examples

County sends the following Batch Numbers:

Day 1 \_\_\_

EXTR0036V6Z361001P200102010901550010

Day 2 -

EXTR0036V6Z361001P200102010901550012

#### Resolution

County should check to ensure that the file with Batch number 0011 has not been mislaid during transfer. If the extract file with batch number 0011 has been mislaid then resend the file to WDTIP. If the extract file was sent in error with batch number 0012 then resend the file with batch number 0011 and Version number 01 and communicate the same to WDTIP. County sends:

EXTR0136V6Z361001P200102010901550011



# Exception

#### Description

The Transaction Code is a unique code that identifies the file Header and trailer section of the extract file. Valid values for the Transaction Code are EXTR for the header section and TRAL for the trailer section. This exception occurs when there are typos in the name of the header or trailer section or the county omits this text from the header and footer sections.

#### Scenario

Napa (county 28) sends WDTIP an extract file omitting the EXTR from the header section and misspelling TRAL by sending TREL instead. WDTIP rejects the record with the 110 exception reason code.

#### Examples

Napa (county 28) sends the following values for the transaction codes in the extract file: ----0028V6Z281001P200002100900000001
TREL0028V6Z281001P20000210090000001000000900

#### Resolution

Napa resends the extract file with corrected Transaction Codes:

EXTR0028V6Z281001P200002110809000001

TRAL0028V6Z281001P200002110809000001000000900

# Description

The county code is a unique 2-digit number that identifies a county sending the extraction file. This exception occurs in either of the two cases described below:

- 1. WDTIP receives an extract file that has an invalid county code in the header and/or trailer.
- 2. WDTIP receives an extract file that has no county code in the header and/or trailer, i.e., the county code field is null.

#### Scenario

Yolo County, which has County Code 57, sends WDTIP an extract file with county code 67 in the header. This file will be rejected.

### Examples

County sends the following:

EXTR0067V6Z361001P200102010901550010

#### Resolution

County resends the file with the correct county code.

<u>Please note – The batch number should remain the same as that of the file that was rejected.</u> The version number should be incremented by 1.

EXTR01**57**V6Z361001P200102010901550010

#### Description

The Account Code data format should be V6ZCC1001P, where CC is the two-digit County Code. This exception occurs when a county sends, in the trailer of the extract file, an incorrect code or blanks for the mandatory, ten-digit Account Code (used by WDTIP for billing).

#### Scenario

Santa Clara (county 43) sends a file to WDTIP, using 58 as the county code in the Account Code portion of the file trailer.

Fresno (county 10) sends a file to WDTIP with blank spaces for the Account Code in the file trailer.

# **Examples**

- 1. Santa Clara sends the following: TRAL0143V6Z581001P2001020109015500020000145678
- 2. Fresno sends the following: TRAL0110V6Z--1001P2001020109015500020000078900

- 1. Santa Clara resends the extract file with the correct Account Code: TRAL0143V6Z431001P2001020109015500020000145678
- 2. Fresno resends the extract file with the correct Account Code: TRAL0110V6Z101001P2001020109015500020000078900
